Promoter

The Promoter is Leakes Road Rockbank Pty Ltd ABN 93 122 773 924 of 25 Aintree Boulevard, Aintree VIC 3336.

Development

The Development is the development known as "Woodlea" situated at Aintree/Bonnie Brook, Victoria 3336/3335.

Terms and Conditions of Promotion

By entering into a Contract of Sale (defined below), the Applicant acknowledges their consent to providing their personal information to the Promoter and agrees to and accept these Promotion terms and conditions.

Promotion Lots

The lots of land subject to the Promotion include all lots for sale during the Promotion Period at the Development in Stages TC6, TC8, 26A, 59, 61, 67 & 78A on the stocklist excluding Townhouses (Promotion Lot).
